Begun and held in Cotabato City, on Monday, the twenty-fourth day of April, two thousand.

[MUSLIM MINDANAO AUTONOMY ACT 102]

AN ACT CREATING BARANGAY LOWER KITANGO IN THE MUNICIPALITY OF DATU PIANG, PROVINCE OF MAGUINDANAO, AUTHORIZING THE APPROPRIATION OF FUNDS THEREFOR, AND FOR OTHER PURPOSES.

Be it enacted by the Regional Legislative Assembly in session assembled.

SECTION 1. Barangay Lower Kitango is hereby created as a separate, distinct and independent barangay from its mother Barangay Kitango in the Municipality of Datu Piang, Province of Maguindanao.

SEC. 2. Barangay Lower Kitango contains a land area of 2,400, 300 square meters, more or less, and is bounded by natural and duly designated boundaries, more specifically described as follows:

“Beginning at a point marked (1) thence N. 45E, 1980m. along Line 2-3 being N.43W, 1120m. along line 3-6 being S.49,59W, 2025.76m. and line 6-1 being S.45E, 1280m.”.

SEC. 3. Immediately after the ratification of this Act, the punong barangay and seven (7) members of the sangguniang barangay shall be appointed by the mayor of Datu Piang Municipality; while, the chairman and seven (7) members of the sangguniang kabataan shall be appointed by the concerned punong barangay: Provided, That they shall hold office until their successors shall have been duly elected and qualified in their next sangguniang regular elections: Provided, Further, That they shall exercise their duties and powers specified under Republic Act 6734, Muslim Mindanao Autonomy Act 25, and other existing rules and regulations.

SEC. 4. The corporate existence of Barangay Lower Kitango shall commence upon the appointment or election and qualification of the punong barangay and a majority of the sangguniang barangay members.

SEC. 5. The Sangguniang Bayan shall provide for the necessary allowances and other benefits of the appointed barangay officials out of the municipal funds until the regular allocation from the national government shall have been released to the new barangay.

SEC. 6. The Commission on Elections shall conduct and supervise the plebiscite, which shall be held within ninety (90) days after the approval of this Act.

SEC. 7. The expenses required for the plebiscite shall be appropriated out of any available funds in the treasury of the Municipality of Datu Piang, Province of Maguindanao, as may be determined by its sangguniang bayan.


SEC. 8. The creation of Barangay Lower Kitango shall take effect when approved by a majority of the votes cast in the plebiscite called for the purpose in the local government units directly affected.

SEC. 9. This Act shall take effect upon its approval.
