THIRD LEGISLATIVE ASSEMBLY
(Sixth Regular Session)

[MUSLIM MINDANAO AUTONOMY ACT NO. 128]

Begun and held in Cotabato City, on Monday the twenty-third day of April, two thousand and one.

“AN ACT AMENDING SECTIONS ONE AND TWO OF MUSLIM MINDANAO AUTONOMY ACT NUMBER ONE HUNDRED FIFTEEN AND FOR OTHER PURPOSES.”

Be it enacted by the Regional Legislative Assembly in session assembled:

SECTION 1. Section one of Muslim Mindanao Autonomy Act Number One Hundred Fifteen is hereby amended, in part, to read as follows:

“The Sitio of Upper Bangkal is hereby created into a separate, distinct and regular barangay out of the existing mother barangay Bangkal in the Municipality of Patikul, Province of Sulu.

SEC. 2 . Section two thereof is hereby likewise amended, to read as follows:

The territorial jurisdiction of Barangay Upper Bangkal is defined by the following description:


