**[MUSLIM MINDANAO AUTONOMY ACT NO. 135]**

**Begun and held in Cotabato City, on Monday the seventh day of  
January, two thousand two.**

**AN ACT REALIGNING THE REGIONAL APPROPRIATIONS  
FOR FISCAL YEAR APRIL ONE TWO THOUSAND ONE  
TO MARCH THIRTY ONE TWO THOUSAND TWO,  
AMENDING FOR THE PURPOSE SECTION ONE OF  
MUSLIM MINDANAO AUTONOMY ACT NUMBERED  
ONE HUNDRED TWENTY THREE AND FOR OTHER  
PURPOSES.**

**Be it enacted by the Regional Legislative Assembly in session assembled.**

**SECTION 1. Muslim Mindanao Autonomy Act Numbered One Hundred  
Twenty Three, particularly Section One thereof, is hereby amended to read as  
follows:**


