[ **MUSLIM MINDANAO AUTONOMY ACT NO. 147** ]

Begun and held in Cotabato City, on Monday, the twenty eighth day of October, two thousand two.

**AN ACT CREATING BARANGAY POBLACION II IN THE MUNICIPALITY OF SHARIFF AGUAK, PROVINCE OF MAGUINDANAO, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES.**


Be it enacted by the Regional Legislative Assembly in session assembled:

SECTION 1. The sitios of Dondoy, Taib and Mamagayon are hereby created into separate, distinct and regular Barangay to be known as Barangay Poblacion III in the Municipality of Shariff Aguak, Province of Maguindanao, from its mother Barangay Poblacion

SEC. 2. Barangay Poblacion II shall be bounded by natural and duly designated boundaries with a total area of 287.04 hectares, more specifically described as follows:

“From the point of origin, Point 1, the line moves due Northwest bearing 29°51’ for approximately 800 meters towards Point 2 along Barangay Limpongo; thence continuously moving Northwest at 4,482.02 meters bearing 87°44’ along Barangay Satan towards Point 3; thence going Southeast bearing 30°29’ for 400.28 meters to Point 4; thence continuing 1,591.15 meters Southwest bearing 74°49’ to Point 5; thence going continuously Southwest for 2,750 meters bearing 87°44’ closing the traverse going back to the point of origin, Point 1.”

SEC. 3. As created, the corporate existence of Poblacion II shall commence upon the appointment of the punong barangay and majority of the members of the Sangguniang Barangay.

SEC. 4. The punong barangay and seven (7) members of the Sangguniang Barangay shall be appointed by the Mayor of the Municipality of Shariff Aguak immediately after the ratification of this Act.

While the chairman and seven (7) members of the Sangguniang Kabataan shall be appointed by the punong barangay concern after consultation with the Mayor and DILG-ARMM.

All concerned shall hold office and perform their respective functions in accordance with MMA Act No. 25 until their successors shall have been elected and qualified in the next barangay and SK regular elections.

SEC. 5. The Sangguniang Bayan shall provide for the necessary allowances and other benefits of the appointed barangay officials from any available municipal funds until their regular allocations from the Internal Revenue Allotment shall have been released by the national government.


SEC. 6. The Commission on Elections (COMELEC) shall conduct and supervise the plebiscite for the purpose in the affected areas upon the request of the Municipal Mayor within ninety (90) days after the approval of this Act.

SEC. 7. The expenses necessary in the holding of plebiscite for the purpose shall be appropriated by the Sangguniang Bayan from any available funds in its Municipal Treasury.

SEC. 8. The creation of Barangay Poblacion II shall take effect when approved by majority of the votes cast in the plebiscite called for the purposes.




