MUSLIM MINDANAO AUTONOMY ACT NO. 207

Begun and held in Cotabato City, on Monday, the 30th day of October, two thousand six.

**AN ACT APPROPRIATING SUPPLEMENTAL FUNDS FOR
THE OPERATION OF THE AUTONOMOUS
GOVERNMENT IN MUSLIM MINDANAO FOR
FISCAL YEAR 2006 IN THE TOTAL AMOUNT OF
THIRTY FIVE MILLION PESOS (P35,000,000.00),
AND FOR OTHER PURPOSES.**

Be it enacted by the Regional Legislative Assembly in session assembled:

SECTION 1. Appropriation of Funds. - The amount of **THIRTY FIVE MILLION PESOS (P 35,000,000.00)** is hereby appropriated as supplemental budget for fiscal year 2006 out of the local funds for the operation of the Regional Government.
