**RESOLUTION ADOPTING A CALENDAR OF SESSION FOR THE
FIRST REGULAR SESSION OF THE NINTH LEGISLATIVE

WHEREAS, Section 2, Rule I of the Rules of the Assembly provides:

“The Assembly shall convene once every year on the first Monday of August for its regular session, unless a different date is fixed by law, and it shall continue to be in session for such number of days as it may determine through its legislative calendar: Provided, that a regular session shall end not later than thirty (30) days before the opening of the next regular session, exclusive of Saturdays, Sundays and legal holidays;”

WHEREAS, adopting a Calendar of Session will guide the Members of the Ninth Legislative Assembly in the performance of their legislative and constituency-servicing functions.
